The RENTER/USER hereby confirms & acknowledges that the YAS does not provide security for the facilities. The RENTER/USER hereby confirms & acknowledges that use of /or work within or on the facility involves inherent risks and dangers' including loss of property and damage to property and the RENTER/USER freely accepts & assumes all risks of the possibility of property loss and or damage or loss resulting there from.

**In consideration** of the YAS permitting the RENTER/USER access to the YAS facilities or grounds the RENTER/USER agrees as follows:

1. The RENTER/USER does hereby release, remise and forever discharge, and agrees to indemnify and save harmless the Yellowhead Agricultural Society, its executives, directors, officials, employees, agents, servants and representatives (hereinafter referred to as "YAS") from and against all claims, actions, costs, expenses, legal fees and demands made by anyone in respect of property loss or damage or loss resulting here from, howsoever caused, arising out of or in connection with or during the use of the facility notwithstanding that the same may have been caused by contributed to or occasioned by the negligence, breach of contract, breach of common duty of care as an occupier of premises, or otherwise, of or by the YAS any of them.
2. The User agrees that by signing this agreement, the use of such equipment or facility may be construed as an event or program supported by the YAS. As such, the User/Renter agrees to protect and promote the reputation and public regard of the YAS in a favourable manner, and will make every effort to ensure that no defamation of character damage is directed towards the YAS or its' officers, employees, servants, agent, contractors, or volunteers.
3. The RENTER/USER waives any and all claims in respect of loss or damage to any property the RENTER/USER has or may have in the future against YAS.
4. The RENTER/USER agrees to assume all risks to property, both known & unknown, and all consequences thereof, arising out of or in connection with the use of the facility.
